June 1, 2019 Tournament Rules

I. Participants and Eligibility

- A. Contestant must complete, sign and submit an official entry form along with the \$100 entry fee per team to Mn Adult & Teen Challenge, 2424 Business 371, Brainerd, MN 56401. Or, register online at mntc.org/fishing. Confirmations will be mailed or emailed
- B. Contestants may pay with check, money order or credit card.
- C. This is a two-person per boat fishing tournament. If both contestants are under age 16, a non-fishing guardian or parent must be present
- D Contestants must attend the Friday, May 31, 2019 Rules Dinner at Heritage Assembly of God church in Baxter. Special fishing trips and other adult and youth contestant prizes will be awarded by draw at the rules meeting. E. Sponsorship funds (100 % tax deductible)
- raised to support Teen Challenge must be submitted prior to or at registration. Top fundraisers win fishing trips with Al Lindner. Steve Pennaz and Den Pluimer. The minimum amount requested that each team raise is \$500; there is no maximum.
- F. A very attractive raffle with tickets available to all teams makes fundraising even easier.
- G. Contestants over 16 must possess a valid Minnesota fishing license.

II. Sponsorship Materials

- A. Teams are urged to begin the fundraising process as soon as possible. Submit funds early! Teams may continue fundraising up to tournament time, and submit additional contributions at registration.
- **B**. When you register online, an automatic online donation page will be created for your team. Call David, 218-833-8752 for suggestions and assistance.
- **C**. A DVD will be part of each confirmation packet. Share the DVD with friends, church family, businesses, groups, etc., to enhance fundraising and attract new teams.
- **D**. Envelopes will be provided when teams register. Funds should be sent to Mn Adult &Teen Challenge as they are raised

III. Scoring

- A. Anglers must declare before fish are weighed which division they intend to enter.
- **B**. The "Mixed Bag" division may be entered, but excludes the team from entering in other divisions. "Mixed Bag" of one panfish, one walleve, one bass and one pike must be declared at weigh-in.
- **C.** In the panfish division, teams may weigh a maximum of three panfish (bluegill, sunfish, crappie or perch in any combination). Teams may weigh three walleyes in the walleye

division. Teams may weigh three largemouth in the bass division. Teams may weigh only one northern pike in the pike division.

- **D**. One rock bass will be the bonus "kicker" fish and added to each division
- E. Weigh-in headquarters: Cragun's Resort on Gull I ake
- **F**. Ties will be settled by a coin toss.
- G. Plagues will be awarded for the ugliest fish.

IV. Tournament Format

- **A**. Tournament boundaries are the entire Gull Lake Chain.
- B. Launch at any ramp.
- C. Scales open at 1 p.m. Teams may weigh
- a limit for any species only once. D. Contestants may be on the water and at
- their fishing destinations, but may not begin fishing until 7 a.m. E. All boats must return to Cragun's Resort
- no later than 3 p.m.
- **F**. Teams returning earlier than the 3 p.m. deadline will streamline the weigh-in process. **G**. Artificial lures and live bait are allowed.
- H. Each competitor must observe safe boat conduct, no-wake zones, local navigation rules, demonstrate courtesy and act in a sportsmanlike manner.
- I. The tournament director will interpret rules according to the spirit and intent of the rule and his decision in all matters is final.
- J. All prizes and trophies will be awarded from the weigh-in stage immediately upon completion of the tournament. Winners must be present to collect prizes or they will be forfeited. Each team will be entitled to win one maior prize.
